**RECONSTRUCTION OF TAXIWAY ALPHA (WEST PORTION)
MERCEDITA AIRPORT

In accordance with Act 125 of May 7, 1942, as amended, and Regulation 8981 of PRPA Bids and Request for Proposals, the Puerto Rico Ports Authority (PRPA) is requesting competitive bids from contractors, for the project referenced above.

The project consists of the reconstruction of the west portion of Taxiway Alpha on Mercedita Airport, Ponce, Puerto Rico. A portion of Taxiway A will be fully demolished and repaved, while other section will be milled and overlay. Installation of new edge light fixtures, pavement underdrain, and pavement marking are also part of the scope. All in accordance with contract documents and technical specifications.

Bidders of this project shall submit the Proposal in accordance with the Instructions to Bidders contained in the Contract Documents, until June 5, 2018 at 10:00 AM, (PR Time). A pre-bid conference will be held on May 29, 2018 at 1:30 P.M (PR Time) at the Conference Room of the Engineering Bureau Building at Isla Grande, San Juan, PR. PRPA strongly encourages prospective bidders to attend the pre-bid conference.




The Drawings, Specifications and other contract documents for this project, on electronic format, can be obtained at the Engineering Bureau Building of the Puerto Rico Ports Authority Central Office, Phone Number (787) 729-8715 extension 3184, until June 1, 2018 by paying a nonrefundable amount of two hundred dollars (\$200.00) in cash or certified check to the Puerto Rico Ports Authority. Bidders are advised that they must be registered as possessors of the contract documents for the project and possessors of all such amendments.

All bids received, will be publicly opened and read aloud by the Bids Board at the Conference Room of the Puerto Rico Ports Authority Engineering Bureau Building at Isla Grande, San Juan, PR, at the same day of the Bid Opening.

The project is conditioned upon the receipt of federal funding under provisions of the Federal Aviation Administration (FAA) Airport Improvement Program (AIP). Certain mandatory federal requirements apply to this solicitation and will be made part of any contract awarded.
