Achieving sustainable economic and social development in Puerto Rico is intrinsically related to a strengthened health system and health service delivery network with the necessary financing. This requires:



Integrated and coordinated **planning** of strategies for economic development and public health,




Necessary and stable **financing** to implement strategies to boost the economy, as well as the health and well-being of the population (e.g., Medicaid and Medicare programs).



Effective integration of the health services providers **network**, considering the needs of diverse groups and regions in Puerto Rico.

Optimization and **transparency** in the use of funds and current opportunities due to COVID-19 and other available funds.

Ensure the **integration** of and compliance with prevention protocols and guidelines.


Continue COVID-19 **Vaccination** efforts and re-immunization strategies for other vaccines:

Eliminating uncertainty in financing key health strategies for the economy and wellbeing - Funding parity: Medicaid and Medicare



Working together to permanently allocate Medicaid funds before October 1st, 2021.

Failure to achieve this could result in:

- **Vulnerability** in **access** to health services and **coverage** for several population groups that are part of the Government Health Insurance Plan,
- An environment of **instability** and **dislocation of economic multiplier effec**t in all components of the health service delivery system,
- Limited ability to reinforce a long-term vision and continuity in these programs.
- Negatively impacting the critical sustainability measures implemented in FY 2020-2021.

Eliminating uncertainty in financing key health strategies for the economy and wellbeing - Funding parity: Medicaid and Medicare



For Medicaid specifically, ensure compliance with the program integrity measures, eliminate the funding cap and Federal Medical Assistance Percentage (FMAP) to be on par with other states. In addition, expanding benefits of:

 Long-term Care, Payment of the Part B premium for the Dual population, Home Care, Non-Emergency Medical Transportation, Immunizations for the elderly (CDC), and emergency services for legal / undocumented aliens.



Achieve increase in the Platino 'wrap-around payment' for the Dual population.




Make Medicare Advantage rates equal to, at least, that of the US Virgin Islands.



End exclusion of Puerto Ricans from the Medicare Part D Low Income Subsidy (LIS) program to provide access to medicines to low-income patients.
