WORK COMMITTEES

The day-to-day work of the Puerto Rico Chamber of Commerce is carried out through its Working Committees, which are responsible for studying the situations and challenges that directly or indirectly affect the development of the private sector, while proposing viable solutions and alternatives.

Each committee is aligned with a specific economic activity or area of interest to the membership. All PRCC members and their designated representatives are eligible to participate in the committee(s) of their choice.

The President of the PRCC appoints the chairpersons of each committee for a one-year term and communicates the key issues that will shape the committee's work agenda for the fiscal year. Committee chairs are expected to focus their efforts on these priorities and seek the collaboration of volunteer resources to help accomplish the agenda. If the committee's goals are not met within the year, chairs should submit relevant recommendations to ensure continuity of efforts in subsequent fiscal years.

ADVOCACY

The presence and participation of the PRCC in matters affecting the private sector is an essential part of its mission. We are committed to maintaining an active presence before the Legislative Assembly and other government and private entities to defend the interests of this sector and support legislation that benefits it.

We do this by strictly adhering to the principles of free enterprise and sustainable economic development as outlined in our Bylaws and Assembly Resolutions. Each measure is evaluated based on its impact on the economy and commerce, excluding any political or partisan motivations. Our goal is to strengthen the development of our members by providing knowledge, multisectoral representation, and protecting the core values of the private sector.

We have established key partnerships that allow us to maintain a presence in Washington, D.C., on highly important issues such as healthcare funding (Medicaid, Medicare), nutritional assistance programs, and others. These alliances with nonprofit organizations have expanded our reach and helped amplify the Chamber's voice to broader audiences.

The PRCC also keeps its members informed about important legal developments through publications, email updates, articles, and informative events.

Scope of advocacy:

- Negotiate and support legislation favorable to the private sector.
- Stop legislation or unfavorable determinations that affect economic development and businesses.
- Prepare and present testimony before legislative committees.
- Appear at legislative and government agency public hearings in order to set forth the Chamber's position.
- Support and lobby in favor of the private sector at the municipal level, the courts or any competent forum.
- Report on legislation in progress.
- Report new laws that impact the business sector.
- Meet with government leaders to discuss and find development alternatives for the private sector and the economy.

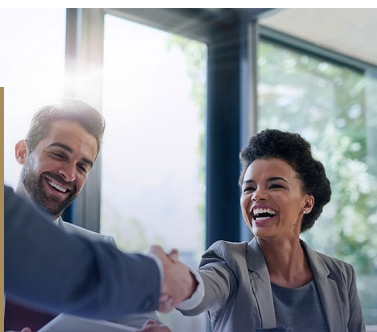

Since 1913, the Puerto Rico Chamber of Commerce (PRCC) has been guided by its core mission: to defend the free enterprise system, under the premise that the government should serve as a catalyst in the promotion of business.

Likewise, the government's regulatory role should become a facilitator, enabling the private sector to effectively carry out its functions of producing and distributing goods and services. This will help generate employment and foster the quality of life our communities need to advance progress for all in Puerto Rico.

In addition to its membership base of over 600 partners, the PRCC includes 38 affiliated business and professional associations representing all branches of Puerto Rico's productive sectors. These associations form what is known as the Council of Affiliated Associations, making the PRCC the organization that best represents the business sector in the island.

The work of the PRCC is led by its Board of Directors, composed of business leaders, professionals, and representatives from affiliated associations covering all areas of economic activity. The organization's operations are governed by the general policies and strategic plans established by the General Assembly of Members, the Board of Directors, and the President of the Institution.

Important:

- ▶ The application must be completed digitally in English. The system will calculate your annual membership fee based on your company's annual business volume. Once payment is submitted, the evaluation process will begin.
- ▶ Up to five (5) voting representatives are allowed per company or association.
- ▶ Participation in the Working Committees is renewed annually. Join the PR Chamber of Commerce Committees! Your involvement is key to advancing Puerto Rico's economic and social development.
- ▶ All applications will be reviewed by our Membership Committee and subsequently submitted for approval by our Board of Directors, which meets regularly once a month. Once approved, you will receive an official welcome letter with your membership number and additional details.
