



- "The people are a light-hearted, simple-minded, harmless, indolent, docile people, and while they gamble and are fond of wine, women, music, and dancing, they are honest and sober. They seem to realize that labor there has no reward, and that their existence is not much improved by the small share they receive of what they produce. Statehood Achieved	1959	N/A


# Errors and Unintended Consequences of US Rule

# But Puerto Rico is Richer than Neighboring Countries






### Newfoundland and Labrador: A Possible Template



- 1907: Self governing British dominion
- 1932: Required bailout by British and Canadian governments
- 1934 1949: Ruled by appointed commission
- 1949: Voted to join Canada as a province



# Newfoundland v. Puerto Rico



Newfoundland and Labrador	Puerto Rico
Appointed commission replaced elected government	Oversight board empaneled to work with elected government
Commission resolved Newfoundland's debt	Courts have partially resolved Puerto Rico's debt
Population Increase	Population Decline
British government authorized national convention and referendum	Six non-binding plebiscites since 1967

### US Citizenship After Independence?



"After the effective date of independence citizens of Puerto Rico seeking to enter into the United States or obtain citizenship in the United States shall be subject to the immigration laws of the United States."



# Puerto Rico as a Well Functioning State



- Get past the bankruptcy
- Prevent a future financial crisis, through:
  - Budget process reform
  - Improved financial reporting
  - Address problems at other public entities

# Getting Past the Bankruptcy



- Bankruptcy process still ongoing after six years
- Need to finally resolve the PREPA bankruptcy
- And: Meet requirements to dissolve the Oversight Board

An Oversight Board shall terminate upon certification by the Oversight Board that ... [the] government has adequate access to short-term and long-term credit markets at reasonable interest rates to meet ... borrowing needs

### **Budget Process Reform**



- 49 of 50 US states have a constitutional balanced budget requirement
- Puerto Rico was supposed to have one as well, but it got lost in translation

"Total Revenues" <> "Recursos Totales"

# Improved Financial Reporting



- Most states produce audited financial statements within 250 days of fiscal year end
- For FY 2021, Puerto Rico took 712 days


