Synopsis

This Privacy Notice is intended to explain what information the Puerto Rico Chamber of Commerce (PRCC, We, Us, or Our) collects, how it is used, and your rights regarding that information, along with any additional notices provided at the time of collection.

The "PRCC" strives in respecting the privacy rights of all businesses and individuals. It is also committed to using business and personal information responsibly in accordance with applicable laws.

To ensure that information is collected, processed, and protected in a responsible manner, we have implemented governance and privacy measures for which we kindly request your understanding of this Privacy Notice.

The following policy pertains to information collected from participating companies, agents, PRCC officials, guests, and other members who interact with our organization. At "PRCC," we recognize the importance of protecting your business and personal data. We strive to implement reasonable measures to safeguard your information from unauthorized access, use, or disclosure.

While no system can guarantee absolute security, we are committed to continually improving our data protection practices to ensure your information is handled responsibly and securely.





6. PRIVACY

BizData Book is committed to protecting any confidential information that is not intended to be published, if identified as such by the participating company. Confidential information will not be shared with third parties without the express consent of the participant.

7. INCLUSION IN RANKINGS.

Joining BizData Book does not guarantee that your company will be included in the ranking.
